# **Examination Notice Under IV Act - 1917**

- ➤ Inland vessels examinations of Deck & Engine Side for the year 2016 will be conducted under Inland vessels Act, 1917. The details of application forms and related schedule are as follows:-
- ➤ Board of Examinations for Seafarers Trust, 303, Mayuresh Chambers, Plot No. 60, Sector-11, CBD Belapur, Navi Mumbai on behalf of Maharashtra Maritime Board, will issue **application forms** / **receive filled in application forms** for the examination of **all grades** such as Serang, 2<sup>nd</sup> Class Master, 1<sup>st</sup> Class Master, 2<sup>nd</sup> Class Engine Driver, 1<sup>st</sup> Class Engine Driver and License to act as Engineer.
- Candidates, who desire to appear in any grades of IV-examination is required to pay the "Assessment Fee" applicable for the grade in the form of "Demand Draft" only, drawn in favor of "BES Trust Examination Fees AC" payable at Mumbai and collect the "Application Form" from BES office. You may please note that "Application Form" is free of cost and no money will be charged from the candidates for issuing the application form.
- ➤ It is preferred that candidates must submit their filled in application by hand in BES Office. However, candidates, who may desire to send their application forms to BES through registered post / Courier, can do same by downloading the form available on BES website. Last date for receiving application forms through post is 15<sup>th</sup> December, 2015, forms received after the due date will not be entertained.
- Application forms received by Post/Courier, after the cut-off date will not be entertained. BES will have its right reserved to cancel such application forms without communicating any information to candidate.
- ➤ While submitting filled in application forms, candidates are required to submit **Original+'Xerox copy of** 1<sup>st'</sup>**page** of application form.

- 1) Applicants must comply with the Instruction given on page 4 in the Application form and with eligibility criteria uploaded (available) on BES website www.seafarers.edu.in

- 3) "Assessment Fee" to be paid by **Demand Draft only,** from any bank.
- 4) Applicant should be of 21 year of age when submitting the application form, supported with SLC (School Leaving Certificate) or Birth Certificate (attested Xerox copy)
- 5) Candidate must submit Sea Service Certificate on the company letter head only. Prior to submitting the Sea Service Certificate, candidate must ensure that the "Sea Service Certificate" has been signed only by the authorised signatory of a registered company. The certificate should be duly signed and stamped.
- 6) Candidate must submit Original Medical Certificate issued by DGS approved Medical Examiners as describe in the eligibility criteria available on BES website.
- 7) Candidates must submit the copy of Safety Courses as describe in the "Eligibility Criteria" which is available on the BES website.
- 8) "**Proof of Permanent Address**" to be attached by the applicant (Self attested, Xerox Copy).
- 9) After assessment of the documents the name of **eligible / not eligible / Hold** candidates will be displayed on the BES website **www.seafarers.edu.in** minimum of 30 days after the last date of submission of application form in BES.
- 10) Only eligible Candidate to pay the examinations fee by **Demand Draft** as mentioned above.
