- 11. Candidates from various Government organizations must submit their "SEA SERVICE CERTIFICATE" *in original*, duly signed by the authorised signatory and attach with application form.
- 12. All IV-candidates working for private owners, will be required to submit "Notarized Affidavit" on Non Judicial Stamp Paper of Rs. 100/- and this affidavit is to be signed by the owner of the company / vessel regarding the sea service certificates of the candidates and to be sent along with the application forms to Board of Examinations for Seafarers Trust (BES).
