- 7. All candidates are required to obtain the SEA SERVICE CERTIFICATE from their employers, duly signed by the authorized person and stamped. They must prepare NOTARIZED AFFIDAVIT on Rs.100 stamp paper of the sea services and attach the ORIGINAL sea service certificate along with ORIGINAL notarized affidavit to the Application Form. The candidate must ensure that all required information in the application form is provided.

- 8. The fees for the examinations are to be paid by the candidates in three parts. First part Assessment Fee and Second Part Examination Fee and lastly Third Part Certification Fee.

The payment has to be made through "Demand Draft" drawn from any major public / private banks in favor of "BES TRUST EXAMINATIONS FEES AC".
