**NOTICE**


1. **Board of Examinations for Seafarers Trust (BES), Navi Mumbai** functioning under the authority of the DG Shipping, GOI is entrusted by DG Shipping, Mumbai to carry out the examinations for VPT marine crew under the supervision of the DC of the port.
2. BES will conduct the examinations as per the Visakhapatnam Port (Harbour Craft) Rules, 2015 for Grades- 1<sup>st</sup> Class Master, 2<sup>nd</sup> Class Master, Serang, 1st Class Engine Driver and 2<sup>nd</sup> Class Engine Driver.
3. A candidate shall be examined *Viva Voce* as to his knowledge in the subjects of grade appearing.
4. BES invites filled in Application Forms from the port crew desirous of appearing the examination for grades mentioned above.
5. A candidate who desires to appear the examination is to download the following from BES web site [www.seafarers.edu.in](http://www.seafarers.edu.in).
  - a) *Application Form*
  - b) *Sample copy of Service Certificate*
  - c) *Checklist*
  - d) *Eligibility Criteria*
6. The candidate shall first, go through the eligibility criteria and the Application Form. Fill in the Application Form, attach all necessary testimonials mentioned therein, put his signature before the responsible officer of the port, complete the checklist and hand over the full set at port office for onward dispatch to BES.
7. The candidate shall obtain the **SERVICE CERTIFICATE** in the given format from the records of the port trust, get it signed by the DC or the officer authorized by him, stamped and attach to the application form.

All candidates are required to undergo Medical Examinations by a DGS Approved Medical Examiner as detailed in the Eligibility Criteria. The **ORIGINAL** medical certificate of the doctor is to be attached to the Application Form.
9. BES will collect the examination fee from the candidates two times as Assessment fee and thereafter, as Examination fee. The examination fee will only be collected from a candidate if he is found eligible to appear the examination for the grade applied.

10. The candidate shall first, pay the assessment fee for the grade applied through DD amounting to as shown in the below table, drawn from any nationalized banks or major private banks. The DD shall be made payable at Mumbai and demand pay to **BES Trust Examinations Fees A/C**. The candidate shall write his name and grade applied for on the backside of the DD and shall attach it to the Application Form.

12. Application Form received incomplete will not be processed.
13. Any Application Form received with false information or found at a later date with false information will be rejected, certificate of competency (COC) if issued, will be withdrawn and the candidate will be liable for punishment as per the law.
