## Circular No. 01 of 2022

**Subject :** Corrigendum to Circular No. 02 of 2021 Re-validation of certificate of Competency under Inland Vessel Act, 1917 as amended.

In order to revalidate the expired Certificate of Competency, issued by Maharashtra Maritime Board, under the Inland Vessel Act, 1917 as amended, the Board issued the procedure for the revalidation of Certificate of Competency vide circular no. 02 of 2021.

As per clause no.1(c) of Circular 02 of 2021 it was directed that *"The candidate shall undergo a revalidation course from IMU, Mumbai campus and submit certificate of completion of the revalidation course for the relevant grade, such certificate shall not more than six months old."*

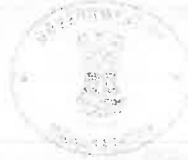

**Circular No.02 of 2021**

**Subject:** Re-validation of Certificate of Competency under Inland Vessel Act,1917 as amended.

In order to revalidate the expired Certificate of Competency, issued by Maharashtra Maritime Board, under the Inland Vessel Act,1917 as amended, following process is to be implemented.

1. The holder of Certificate of Competency shall submit following documents alongwith the application for revalidation of Certificate of Competency: -
  - a) An affidavit proving service on an Inland Vessel for a minimum period of one year during the preceding five years;
  - b) The candidates shall submit the copies of re-fresher courses for 5 basic STCW courses from a DGS approved institute;
  - c) The Candidate shall undergo a revalidation course from IMU, Mumbai campus and submit certificate of completion of the revalidation course for the relevant grade, such certificate shall not be more than six months old.
  - d) A valid medical certificate from a DGS approved medical practitioner.
2. On processing of the documents, the Certificate of Competency shall be revalidated for next 5 years.
