

EXAMINATION NOTICE

(For GP & CCMC Repeater Candidates)

1. BES will be holding the examination in **June 2024** for the Fresh & Repeater candidates at its examination centres at **Mumbai, Kochi, Goa, Delhi, Kolkata and Chennai**.
2. We draw the attention of GP and CCMC Repeater candidates to DGS Training Circular No. 1 of 2018, dated 22.01.2018 (Annexure 6, Para. 4). The GP & CCMC candidate is allowed to take total number of Seven attempts including the first attempt as a fresh candidate.
3. BES invites completed Application Form from the eligible “GP and CCMC REPEATER CANDIDATES”, desirous of appearing in the examination scheduled, tentatively in **June 2024**.
4. The candidates applying for the examination must use only BES repeater application forms. These forms are **QFRE 17(A) (GP), dated 01.01.2024 and QFRE 16(A) (CCMC), dated 01.01.2024**. These forms have been uploaded on our web-site along with this Notice. A candidate may download the respective form, take a print out and fill in the details. **All candidates must write personal email id and mobile number in the designated space of the application form and the same should be legible.**
5. **Candidate must attached the self attested photocopies of mandatory STCW/STSDSD courses along with application form for complying with eligibility requirement to appear for the examination.**
6. The candidate shall pay the examination fee using **QR code** provided on the Application Form.

Informatively, the Fees is prescribed in the application form for each part of examination and a candidate appearing for more than one part of exam, must pay fees, totalling all the parts, for which he/she desires to appear.

BES will publish the names of the eligible candidates along with subjects to be examined, on its web-site. **Admit cards will be issued to the eligible candidates at the examination center, admit Cards are also being uploaded on www.bestrust.in**. The Procedure for downloading admit cards will be intimated later.
9. All candidates must report in uniform, at the examination centre. The candidates who are reappearing for Practical and Oral examination, must wear proper PPE (Boiler suit, Safety shoe, etc). **No candidate will be examined to his/her practical and oral examination in case of not wearing proper PPE.**
10. Last date for receipt of Application Form at BES is **20th May 2024**. Please note that **any application form will not be accepted after the last date.**
11. Application Form received with any false information will be summarily rejected, and the candidate will be liable for punishment as prescribed.
12. **Candidate must fill all required particulars in the application form. Incomplete application forms will also be summarily rejected.**
