## Circular No. 02 of 2023

**Subject:** Standard operating procedure is formulated for the purpose of issuing C.O.C under IV Act to candidates holding Bluechit issued by M.M.D-Mumbai, (Department of DG Shipping) before year 2004 and their records are not presently available with MMD-Mumbai for verification.

This circular is issued to streamline the grievances of the candidates and provide them with necessary relief on the subject. Since the authenticity of Bluechit issued by MMD-Mumbai before year 2004 cannot be verified and same is a concern for MMB and it's a need to cross check the competency of such candidates for which conducting of oral exam is needed. Hence following standard operating procedure (SOP) is prepared for issuance of C.O.C under IV Act to the candidates having Bluechit issued by MMD-Mumbai before year 2004.

Procedure which needs to be adhered to is as follows:

- 1. Candidate must have a minimum of 05 years of sea service from the time of issuance of Bluechit.
- 2. Candidate must have completed following Basic STCW courses:

i) Elementary First Aid (EFA)

ii) Proficiency in Survival Techniques (PST)

iii) Personal Safety & Social Responsibility (PSSR)

iv) Fire Prevention and Fire Fighting (FPFF) and

v) Security Training for Seafarers with Designated Security Duties.

3. Candidates must undergo D.G. approved Medical examination.

- 4. Candidates must have a revalidation completion certificate from IMU, Mumbai for the Grade mentioned in his BlueChit.
- 5. Candidates must submit original BlueChit issued by M.M.D Mumbai.

Once candidate comply with above mentioned 5 steps, he will submit application/documents at Board of Examinations of Seafarers Trust and once all submitted documents found satisfactory, he need to undergo and Pass the Oral exam for the particular Grade as mentioned in his Bluechit, basis which he will be issued a C.O.C under IV Act by MMB with Validity of 5 Years. Detail procedure for application and oral exams will be available on B.E.S website. (https://seafarers.edu.in)

This Circular validity is effective for a duration of 12 months starting from the date of its issuance.

Sub - Process of issuing CoC under I V Act to candidates holding Bluechit issued by MMD, Mumbai issued before year 2004.

Sir.

This refers to MMB circular dated 28.07.23, to address the grievances of the candidates and provide them with necessary relief on the subject. Following process is suggested for the issuance of CoC under IV Act, to the candidates is Possession of Bluechit, issued by MMD, Mumbai, before the year 2004.

- 1. The candidate shall apply to BES by filling up the application form (Available on BES Website) with following documents.
  - a) Provide evidence of sea service on Inland Vessel, for a minimum 05 years, from the 'time of issuance of the Bluechit.
  - b) Self-attested copy of refresher course certificates, undertaken at any of the DG shipping approved training institute for 5 basic STCW and STSDSD courses.
  - c) Self-attested copy of valid Revalidation course completion certificate, for the relevant Grade, undergone at the IMU Mumbai campus.
  - d) Valid Medical certificate issued by the DGS approved medical practitioner.
  - e) Self attested copy of Bluechit issued by MMD, Mumbai.
- 2. All applications along with their attached documents, will be assessed and a list of candidates, eligible for Oral examination will be posted on BES website.
- 3. Oral examinations will be conducted alternate month and the schedule will be posted on BES website.
